

**MARKET COMMON CLARENDON  
2019 PRESIDENTS' DAY EVENT  
Official Rules**

**ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS, RULES AND REGULATIONS APPLY. VOID WHERE PROHIBITED. WINNERS WILL BE CHOSEN BASED ON THE STATED CRITERIA. THIS IS NOT A GAME OF CHANCE. NO PURCHASE NECESSARY.**

- 1. EVENT PERIOD:** The 2019 Presidents' Day Event (the "Event") will begin at 1:30 p.m. ET and end at 3:30 p.m. ET on Sunday, February 17, 2019 ("Event Period") at Market Common Clarendon shopping center.
- 2. SPONSOR:** The Contest is sponsored by Regency Centers, L.P. ("Regency" or "Sponsor"), One Independent Drive, Suite 114, Jacksonville, Florida 32202.
- 3. WHO CAN PARTICIPATE:** Children ages thirteen (13) and under can participate (the "Contestant or Contestants"). The age group may be expanded during the Event.
