- 1. SWEEPSTAKES PERIOD:** The Regency Centers Tenant Survey Sweepstakes (the “Sweepstakes”) will begin at 12:00 a.m. Eastern Time (“E.T.”) on Saturday, June 1, 2019 and end at 11:59 p.m. E.T. on Monday, July 15, 2019 (“Sweepstakes Period”).
- 2. SPONSOR:** The Sweepstakes is sponsored by Regency Centers, L.P. (“Regency” or “Sponsor”), One Independent Drive, Suite 114, Jacksonville, Florida 32202.
- 3. ELIGIBILITY:** To enter or win, Entrant must be a legal U.S. resident physically residing in the United States (includes D.C.) who is 18 years of age or older as of June 1, 2019 and a current tenant of Regency or an affiliate (the “Entrant”). Employees, officers, directors, and representatives of Regency Centers, L.P., its parent company, affiliates, subsidiaries, partners, joint venturers, licensees, service providers, advertising and sweepstakes agencies, those involved in the production, development, implementation, or handling of the Sweepstakes, or any agents acting on behalf of the above entities, as well as the immediate family members (parents, children, siblings, spouses) and/or persons living in the same household (whether related or not) of each above-mentioned individual, are NOT eligible to participate in the Sweepstakes.
