- 1. SWEEPSTAKES PERIOD:** The Cirque du Soleil Luzia Tickets Sweepstakes (the “Sweepstakes”) will begin at 12:00 p.m. E.T. on Monday, April 16, 2018 and end at 11:59 p.m. E.T. on Thursday, April 19, 2018 (“Sweepstakes Period”).
