

**CLARENDON DAY SHOPPING SPREE
MARKET COMMON CLARENDON
Official Rules**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. ALL

- 1. SWEEPSTAKES PERIOD:** The Clarendon Day Shopping Spree Sweepstakes (the “Sweepstakes”) will begin at 11:00 a.m. Eastern Time (“E.T.”) and end at 6:00 p.m. E.T. on Saturday, September 22, 2018 (“Sweepstakes Period”).
