Hyde Park Plaza Sweepstakes
Official Rules

- 1. SWEEPSTAKES PERIOD:** The Hyde Park Plaza Sweepstakes (the “Sweepstakes”) will begin at 12:00 a.m. E.T. on Wednesday, November 1, 2017 and end at 11:59 p.m. E.T. on Thursday, November 30, 2017 (“Sweepstakes Period”).
- 2. SPONSOR:** The Sweepstakes is sponsored by Regency Centers, L.P. (“Regency” or “Sponsor”), One Independent Drive, Suite 114, Jacksonville, Florida 32202.
- 3. ELIGIBILITY:** To enter or win, Entrant must be a legal U.S. resident physically residing in the United States (includes D.C.) who is 18 years of age or older as of November 1, 2017 (the “Entrant”). The first winner will receive four (4) \$25.00 gift cards to four separate Hyde Park Plaza retailers of his or her choice. The second winner will receive two (2) \$25.00 gift cards to two separate Hyde Park Plaza retailers of his or her choice. The third winner will receive one (1) \$25.00 gift card to a Hyde Park Plaza retailer of his or her choice. The approximate retail value of all prizes is \$175.00.
