1. SWEEPSTAKES PERIOD: The Carol-Along Sweepstakes (the "Sweepstakes") will begin at 12:00 a.m. E.T. on Tuesday, December 1, 2020 and end at 11:59 p.m. E.T. on Thursday, December 24, 2020 ("Sweepstakes Period").

2. SPONSOR: The Sweepstakes is sponsored by Regency Centers, L.P. ("Regency" or "Sponsor"), One Independent Drive, Suite 114, Jacksonville, Florida 32202.

3. ELIGIBILITY: To enter, Entrant must be a legal U.S. resident (the "Entrant"). In order to win, The Entrant must be the age of eighteen on or before December 1, 2020 or have a legal guardian to claim the prize.
