

**MARKET COMMON CLARENDON
HOLIDAY INSIDER REGISTRATION
Official Rules**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. ALL
FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS, RULES AND
REGULATIONS APPLY. ODDS OF WINNING DEPEND ON THE NUMBER OF
ELIGIBLE ENTRIES TIMELY RECEIVED. VOID WHERE PROHIBITED.**

- 1. SWEEPSTAKES PERIOD:** The Holiday Insider Registration Sweepstakes (the “Sweepstakes”) will begin at 12:00 a.m. E.T. on Tuesday, December 1, 2020 and end at 11:59 p.m. E.T. on Thursday, December 24, 2020 (“Sweepstakes Period”).
- 2. SPONSOR:** The Sweepstakes is sponsored by Regency Centers, L.P. (“Regency” or “Sponsor”), One Independent Drive, Suite 114, Jacksonville, Florida 32202.
- 3. ELIGIBILITY:** To enter, Entrant must be a legal U.S. resident (the “Entrant”). In order to win, The Entrant must be the age of eighteen on or before December 1, 2020. By signing up, you accept and agree to abide by these Official Rules. Sponsor is not responsible for late, illegible, corrupted, or misdirected entries. Entries generated by script, macro, robotic, programmed, or any other automated means are prohibited and will be disqualified.

- 5. PRIZE & APPROXIMATE RETAIL VALUES:** There will be twenty-four (24) prize winners. Each winner will receive a \$100.00 electronic gift card of his or her choice to a retailer located at Market Common Clarendon (some exceptions apply). The approximate retail value of the total prizes is \$2,400.00.

Drawing will be conducted in accordance with the Official Rules by Sponsor, whose decisions on all matters related to the Sweepstakes are binding and final. Potential winner will be notified via email and will be instructed to provide contact information within seven (7) days or the prize will be forfeited and an alternate potential winner will be chosen.
