Official Rules**

- 1. SWEEPSTAKES PERIOD:** The Sing Along Sweepstakes (the “Sweepstakes”) will begin at 12:00 a.m. E.T. on Friday, November 27, 2020 and end at 11:59 p.m. E.T. on Thursday, December 24, 2020 (“Sweepstakes Period”).
- 2. SPONSOR:** The Sweepstakes is sponsored by Regency Centers, L.P. (“Regency” or “Sponsor”), One Independent Drive, Suite 114, Jacksonville, Florida 32202.
- 3. ELIGIBILITY:** To enter, Entrant must be a legal U.S. resident (the “Entrant”). In order to win, The Entrant must be the age of eighteen on or before November 27, 2020 or have a legal guardian to claim the prize. SELECTION OF THE WINNER:** On Monday, Wednesday and Friday of each week between December 2, 2020 and December 23, 2020 (December 2<sup>nd</sup>, 4<sup>th</sup>, 7<sup>th</sup>, 9<sup>th</sup>, 11<sup>th</sup>, 14<sup>th</sup>, 16<sup>th</sup>, 18<sup>th</sup>, 21<sup>st</sup> and 23<sup>rd</sup>), one (1) prize winning entry (for a total of 10 winners) will be selected in a random drawing conducted by Regency from all eligible entries received by the way of the stated entry method. Selection of the prize winning entries shall be made on a random basis and not based on the merits of the submission; provided that Sponsor in its sole discretion may disqualify any entry that does not conform to the requirements outlined above in the "How to Enter" section. Drawing will be conducted in accordance with the Official Rules by Sponsor, whose decisions on all matters related to the Sweepstakes are binding and final. Potential winner will be notified via email or phone and will be instructed to provide contact information within seven (7) days or the prize will be forfeited and an alternate potential winner will be chosen.
