- 1. SWEEPSTAKES PERIOD:** The Imagine Market Common Clarendon Giveaway Sweepstakes (the “Sweepstakes”) will begin at 6:00 p.m. Eastern Time (“E.T.”) and end at 8:30 p.m. E.T. on Tuesday, July 24, 2018 (“Sweepstakes Period”).
