

**THE MARKET AT SPRINGWOODS VILLAGE**  
**Passport Airline Giveaway**  
**Official Rules**

- 1. SWEEPSTAKES PERIOD:** The Passport Airline Giveaway (the “Sweepstakes”) will begin at 11:00 a.m. C.T. on Friday, November 3, 2017 and end at 9:00 p.m. C.T. on Thursday, November 30, 2017 (“Sweepstakes Period”).

any warranty or guarantee claim. Prizes are non-transferable and no substitution of prizes is allowed. All costs and expenses not specified herein related to any prize, including but not limited to delivery, installation, service activation fees, and other expenses incurred by accepting the prize, are the sole responsibility of the winner. **6.
