Official Rules**

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS, RULES AND REGULATIONS APPLY. ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES TIMELY RECEIVED. VOID WHERE PROHIBITED.

- 1. SWEEPSTAKES PERIOD:** The Fallapalooza Giveaway Sweepstakes (the “Sweepstakes”) will begin at 12:00 a.m. E.T. on Tuesday, October 5, 2021 and end at 11:59 p.m. E.T. on Saturday, October 23, 2021 (“Sweepstakes Period”).
