**Official Rules**

**1. SWEEPSTAKES PERIOD:** The Merry at Melody Holiday 2018 Sweepstakes (the "Sweepstakes") will begin at 12:00 a.m. C.T. on Saturday, December 1, 2018 and end at 11:59 p.m. C.T. on Monday, December 31, 2018 ("Sweepstakes Period").

**2. SPONSOR:** The Sweepstakes is sponsored by Regency Centers, L.P. ("Regency" or "Sponsor"), One Independent Drive, Suite 114, Jacksonville, Florida 32202.

**3. ELIGIBILITY:** To enter or win, Entrant must be a legal U.S. resident physically residing in the United States (includes D.C.) who is 18 years of age or older as of December 1, 2018 (the "Entrant").
