

**OAKLEAF COMMONS**  
**FallFest Sweepstakes**  
**Official Rules**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS, RULES AND REGULATIONS APPLY. ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES TIMELY RECEIVED. VOID WHERE PROHIBITED.**

- 1. SWEEPSTAKES PERIOD:** The FallFest Sweepstakes (the “Sweepstakes”) will begin at 11:30 a.m. ET and end at 2:30 p.m. ET on Saturday, October 28, 2017 (“Sweepstakes Period”).
- 2. HOST:** The Sweepstakes will be hosted by Regency Centers, L.P. (“Regency” or “Host”), One Independent Drive, Suite 114, Jacksonville, Florida 32202.
- 3. ELIGIBILITY:** To enter or win, Entrant must be a legal U.S. resident physically residing in the United States (includes D.C.) who is 18 years of age or older as of Saturday, October 28, 2017 (the “Entrant”). SELECTION OF THE WINNER:** On or after October 30, 2017, two (2) prize winning entries will be selected in a random drawing conducted by Regency from all eligible entries received by the way of the stated entry method. Potential winners will be notified either by phone or email and will be instructed to provide contact information within seven (7) days or the prize will be forfeited and an alternate potential winner will be chosen.
