

**CAMERON VILLAGE SHOPPING CENTER**  
**Pop of Music Concert Series Sweepstakes**  
**Official Rules**

**1. SWEEPSTAKES PERIOD:** The Pop of Music Concert Series Sweepstakes (the "Sweepstakes") will occur weekly beginning on Monday, August 20, 2018 and ending on Friday, September 7, 2018 ("Sweepstakes Period"). The weekly periods will be as follows:

- c. Week 3 - begins at 2:00 p.m. E.T. on Monday, September 3, 2018 and ends at 9:00 a.m. E.T. on Friday, September 7, 2018 ("Week 3") (collectively, "Weekly Period" or "Weekly Periods").

**2. SPONSOR:** The Sweepstakes is sponsored by Cameron Village Merchants' Association ("Sponsor"), 2108 Clark Avenue, Raleigh, North Carolina 27605.

**3. ELIGIBILITY:** To enter or win, Entrant must be a legal U.S. resident, who is 18 years of age or older as of August 20, 2018 (the "Entrant").
