

**MARKET COMMON CLARENDON
PRESIDENTS' DAY GUESS THE NUMBER OF PENNIES
Official Rules**

ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS, RULES AND REGULATIONS APPLY. VOID WHERE PROHIBITED. WINNERS WILL BE CHOSEN BASED ON THE STATED CRITERIA. THIS IS NOT A GAME OF CHANCE. NO PURCHASE NECESSARY.

- 1. CONTEST PERIOD:** The Presidents' Day Guess the Number of Pennies (the "Contest") will begin at 1:30 p.m. ET and end at 3:30 p.m. ET on Sunday, February 16, 2020 (the "Contest Period").
- 2. SPONSOR:** The Contest is sponsored by Regency Centers, L.P. ("Regency" or "Sponsor"), One Independent Drive, Suite 114, Jacksonville, Florida 32202.
