Official Rules**

- 1. SWEEPSTAKES PERIOD:** The Ultimate Tailgate Takeout Sweepstakes (the “Sweepstakes”) will begin at 12:00 a.m. Eastern Time (“E.T.”) on Monday, August 24, 2020 and end at 11:59 p.m. E.T. on Friday, October 16, 2020 (“Sweepstakes Period”).
