1. SWEEPSTAKES PERIOD: The Customer Appreciation Day Sweepstakes (the “Sweepstakes”) will begin at 11:00 a.m. ET and end at 3:00 p.m. ET on Saturday, October 21, 2017 (“Sweepstakes Period”).
