Southbury Green Summer Concert Series Sweepstakes
Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS, RULES AND REGULATIONS APPLY. ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES TIMELY RECEIVED. VOID WHERE PROHIBITED.

- 1. SWEEPSTAKES PERIOD:** The Southbury Green Summer Concert Series Sweepstakes (the “Sweepstakes”) will begin at 3:00 p.m. E.T. on Monday, June 18, 2018 and end at 11:59 p.m. E.T. on Saturday, June 30, 2018 (“Sweepstakes Period”).
- 2. SPONSOR:** The Sweepstakes is sponsored by Regency Centers, L.P. (“Regency” or “Sponsor”), One Independent Drive, Suite 114, Jacksonville, Florida 32202.
- 3. Option 2: A computer with internet access is required for this option. Entrant will visit <http://southburygreenct.com/> to complete and submit the online entry form during the Sweepstakes Period.

Limit of one (1) entry per person either by option 1 or option 2.

By submitting an Entry, you accept and agree to abide by these Official Rules. Sponsor is not responsible for late, illegible, corrupted, or misdirected entries. Entries generated by script, macro, robotic, programmed, or any other automated means are prohibited and will be disqualified.

- 5. PRIZE & APPROXIMATE RETAIL VALUES:** There will be two (2) prize winners. The first winner will receive one (1) \$25.00 gift card to Victoria Secret and one (1) \$25.00 gift

card to Starbucks. The second winner will receive one (1) \$25.00 gift card to Pier 1 Imports and one (1) \$25.00 gift card to The Gap. The approximate retail value of all prizes is \$100.00.

Gift certificate may be subject to additional terms and conditions.

The prize winner is solely responsible for all applicable federal, state and local taxes and/or any other fees/costs associated with the prize or receipt of the prize. Any and all guarantees and warranties for prizes are subject to the manufacturer's and/or service providers terms and conditions, and winner agrees to look solely to such manufacturers and/or service providers for any warranty or guarantee claim.
