

**THE FIELD OF COMMONWEALTH
LUXURY PICNIC GIVEAWAY
Official Rules**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. ALL

REGULATIONS APPLY. ODDS OF WINNING DEPEND ON THE NUMBER OF
ELIGIBLE ENTRIES TIMELY RECEIVED. VOID WHERE PROHIBITED.**

- 1. SWEEPSTAKES PERIOD:** The Luxury Picnic Giveaway Sweepstakes (the “Sweepstakes”) will begin at 12:00 a.m. E.T. on Wednesday, September 15, 2021 and end at 11:59 p.m. E.T. on Thursday, September 30, 2021 (“Sweepstakes Period”).
