The Grove's 3rd Anniversary Celebration Giveaway Sweepstakes
Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS, RULES AND REGULATIONS APPLY. ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES TIMELY RECEIVED. VOID WHERE PROHIBITED.

- 1. SWEEPSTAKES PERIOD:** The Grove's 3rd Anniversary Celebration Giveaway Sweepstakes (the "Sweepstakes") will be between the hours of 11:00 a.m. to 2:00 p.m. on Saturday, September 16, 2017 ("Sweepstakes Period").

- 3. The first five winners will each receive a \$25.00 gift card to the Grove Orlando retailer of his/her choice. The grand prize winner will receive a \$250.00 gift card to the Grove Orlando retailer of his/her choice. The approximate total retail value of all prizes is \$375.00.

The grand prize winner will be selected at 2:00 p.m. as described in this paragraph. Selection of the prize winning entries shall be made on a random basis and not based on the merits of the submission; provided that Sponsor in its sole discretion may disqualify any entry that does not conform to the requirements outlined above in the “How to Enter” section.
